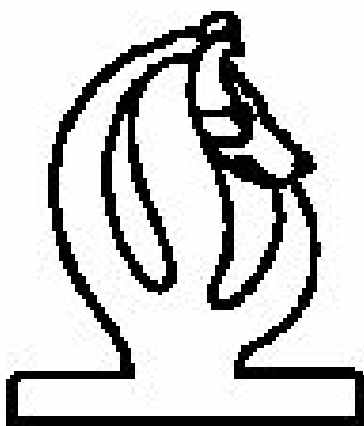

Additional details, including the mask wear policy, will be included in the judging schedule and/or posted and announced at the show site. (Please bring your own mask with you in case the policy changes, as none will be provided.)

Crating will be allowed in the building.

## Notice To Exhibitors

The show grounds will be available Friday for set-up from 5:30 p.m. to 8:00 p.m. The building will open on Saturday and Sunday at 7:00 a.m.

### **\*\*IMPORTANT NOTE\*\***

**Minimal chalking will be allowed in the grooming building. All exhibitors must have floor covering under grooming and crate set-ups. NO BLOW DRYERS allowed in the building.** Exhibitors must provide their own floor covering. Owners and handlers will be held responsible for clean conditions in and around crating area.

Dogs may not be left at the show grounds overnight. Crates may be left.

All dogs present must be on leash or confined to their crates except when being judged.

No strollers or flexi-leads in the building.

Dogs under 4 months of age are not permitted on the show grounds.

No unentered dogs in the building.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.

Free admission/Free parking.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

Dogs may not be left in closed vehicles without proper ventilation. If dogs are found in distress, TRSSCGP will take appropriate action.

## Directions To Show Site

**Please read carefully. Many of the streets are unmarked. Look for "Washington County Fairgrounds" or "Washington Agricultural Fair" signs.**

**FROM I-70 East :** Take Exit 17 (PA 18, Jefferson Ave). At the end of ramp, turn right on to PA 18 North. Follow PA 18 North for 1.3 miles. Turn right at the traffic light just past Jack's Muffler & Brake Shop. Follow road for 0.5 miles to stop sign. Bear left and continue 0.3 miles to Washington County Fairgrounds. Use entrance "C".

**FROM I-70 West:** Take Exit 17 (PA 18, Jefferson Ave). At end of ramp, turn right. Go 0.1 miles and turn right on to PA 18 North. Follow PA 18 North 1.1 miles. Turn right at traffic light. (No street sign, but just past Jack's Muffler & Brake shop on the right). Follow road for 0.5 miles to a stop sign. Bear left and continue 0.3 miles to the Washington County Fairgrounds (on North Main St.). Use Entrance "C".

**FROM I-79:** Take Exit 41 (Race Track Rd). Do NOT take exit 40. Look for the Washington County Fairgrounds or Washington Agricultural Fair signs at the end of the exit ramp. Go west (right turn from I-79 South, or left turn from I-79 North). Go 0.2 miles to a light and make a left turn on to Pike Street. Follow Pike Street for 0.7 miles to a light. Turn right at that light. Follow road for 1 mile to stop sign. Turn right at the stop sign. After 0.1 miles, the road will split - bear left on to North Main. Continue 0.9 miles to the Washington County Fairgrounds. Use entrance "C".
