**Crating and set-up** time will be available on Thursday starting at 2:00 PM. The building will open on Friday at 7:00 AM.

**Judges are not required to wait for dogs.** They will adhere as closely as possible to the Judging Schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when it is scheduled to be judged.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club(s), Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
