- Chalking is to be done outside.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Licensed Events.
- Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.
- All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.
- The Host clubs, the Show Secretary, or their members or agents assume no responsibility for any loss, damage or
 injury sustained by exhibitors, handlers or to any of their dogs or property; and further assume no responsibility for
 any injury to children in attendance.

IMPORTANT! Transfers of dogs from regular classes to Best of Breed/Variety Competition and transfers of dogs
determined to be ineligible for the class in which it has been entered to an Open class (Ch. 11, Sec. 6, AKC Rules
Applying to Dog Shows) must be made to the Show Secretary at least 1/2 hour prior to the start of any regular
conformation judging at this show.
