All dogs present must be on leash or confined to their crates except when being judged. No strollers or flexi-leads in the building.
Dogs under 4 months of age are not permitted on the show grounds of AKC Licensed Events.
Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.

Free admission/Free parking.
Available parking areas will be marked. The neighboring buildings do NOT allow parking in their lots. Vehicles will be towed at owner's expense.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

From NYS Thruway : Take Exit 35. At Carrier Circle, take $2^{\text {nd }}$ exit onto Rt. 298 West. Turn left on Deere Road. We are the $4^{\text {th }}$ building on the left.

From I-81 Northbound: Merge onto I-690 East toward East Syracuse. Take the Thompson Road exit (Exit 16N). Head North on Thompson Road (Rt. 635) to Carrier Circle. At Carrier Circle, take $4^{\text {th }}$ exit onto Rt. 298 West. Turn left on Deere Road. We are the $4{ }^{\text {th }}$ building on the left.

FROM I-81 Southbound: Take I-81 South to NYS Thruway (I-90) East to Exit 35. At Carrier Circle, take $2^{\text {nd }}$ exit onto Rt. 298 West. Turn left on Deere Road. We are the $4^{\text {th }}$ building on the left.
