## Notice To Exhibitors

Show Site Hours and set-up time:

**The building will be available for set-up on** Friday, November 6 from 7:00 p.m.—9:00 p.m.

Saturday & Sunday: The building will open at 7:00 a.m. and close 1 hour after the completion of judging.

### **\*\*IMPORTANT NOTE\*\***

**Chalking will be allowed in the designated garage area ONLY. All exhibitors must have floor covering under grooming and crate set-ups.** Exhibitors must provide their own floor covering. Owners and handlers will be held responsible for clean conditions in and around crating area.

Dogs may not be left at the show grounds overnight. Crates may be left.

All dogs present must be on leash or confined to their crates except when being judged.

No strollers or flexi-leads in the building.

Dogs under 4 months of age are not permitted on the show grounds of AKC Licensed Events.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.

Free admission/Free parking.

Available parking areas will be marked. The neighboring buildings do NOT allow parking in their lots. Vehicles will be towed at owner's expense.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

All persons attending this dog show hereby waive any claim for damages against Central New York Shetland Sheepdog Club, Inc. or it's members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. **From NYS Thruway :** Take Exit 35. At Carrier Circle, take 2<sup>nd</sup> exit onto Rt. 298 West. Turn left on Deere Road. We are the 4<sup>th</sup> building on the left.

**From I-81 Northbound:** Merge onto I-690 East toward East Syracuse. Take the Thompson Road exit (Exit 16N). Head North on Thompson Road (Rt. 635) to Carrier Circle. At Carrier Circle, take 4<sup>th</sup> exit onto Rt. 298 West. Turn left on Deere Road. We are the 4<sup>th</sup> building on the left.

**FROM I-81 Southbound:** Take I-81 South to NYS Thruway (I-90) East to Exit 35. At Carrier Circle, take 2<sup>nd</sup> exit onto Rt. 298 West. Turn left on Deere Road. We are the 4<sup>th</sup> building on the left.

The building is directly across from the John Deere Building and has a sign for Ansum Graphics on the front. The main entrance is on the side facing Court Street Road toward the rear of the building and around the corner from the garage door.
