Judges will take a luncheon break at their discretion, which may impact listed start times.

IMPORTANT: If the published judge and ring are available prior to the listed start time and all exhibitors have checked-in and agree, the judge may start a class earlier than the class time listed in the judging program.

There will be a walkthrough prior to Rally classes, Obedience Beginner Novice, Novice A and Preferred Novice classes. Walkthroughs may be combined at the judge's discretion. Class judging will immediately follow the walkthrough in the order listed.

Three chances to win!

Each event
(Saturday Show 1, Saturday Show 2, Sunday)
will have an “All Arounder Award”

To be eligible for this award, the dog or bitch must be entered in conformation, obedience and rally for a specific show (three shows—Saturday Show 1, Saturday Show 2, Sunday).

The dog or bitch must receive Obedience and Rally qualifying scores (any level) and a 1st place in class in Conformation.

A tie score in Rally will be broken by time.

A tie score in Obedience will be broken by highest class.

Highest award in Conformation (i.e. WD/WB, RWD/RWB) would beat a class 1st place.

Winner for each show receives a free entry (value \$30).

Important “Covid-19” Information Please read!

Show Site convenient to NYS Thruway Exit 35

From NYS Thruway : Take Exit 35. At Carrier Circle, take 2nd exit onto Rt. 298 West. Turn left on Deere Road. We are the 4th building on the left.

From I-81 Northbound: Merge onto I-690 East toward East Syracuse. Take the Thompson Road exit (Exit 16N). Head North on Thompson Road (Rt. 635) to Carrier Circle. At Carrier Circle, take 4th exit onto Rt. 298 West. Turn left on Deere Road. We are the 4th building on the left.

FROM I-81 Southbound: Take I-81 South to NYS Thruway (I-90) East to Exit 35. At Carrier Circle, take 2nd exit onto Rt. 298 West. Turn left on Deere Road. We are the 4th building on the left.

The building is directly across from the John Deere Building and has a sign for Ansum Graphics on the front. The main entrance is on the side facing Court Street Road toward the rear of the building and around the corner from the garage door.

Notice To Exhibitors

The show grounds will be available Friday, November 10, 2023 for set-up from 7:00 PM to 9:00 PM
The building will open on Saturday and Sunday at 7:00 a.m. and close 1 hour after the completion of judging.

Upon entering the building please come to the catalog table to fill out a “Contact” slip to be posted visibly in your grooming or crating area. This is meant for the purpose of reaching you immediately should there be a situation during the show days that requires your immediate assistance. Cell phone numbers are best or your hotel and room number.

****IMPORTANT NOTE****

Chalking will be allowed in the designated garage area ONLY. All exhibitors must have floor covering under grooming and crate set-ups. Exhibitors must provide their own floor covering. Owners and handlers will be held responsible for clean conditions in and around crating area.

No dog washing in the building.
No blow dryers will be allowed in the building.

Dogs may not be left at the show grounds overnight. Crates may be left.
All dogs present must be on leash or confined to their crates except when being judged.
No strollers or flexi-leads in the building.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.

Parking: Available parking areas will be marked. The neighboring buildings do NOT allow parking in their lots. Vehicles will be towed at owner's expense. Free admission/Free parking.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

All persons attending this dog show hereby waive any claim for damages against Central New York Shetland Sheepdog Club, Inc. or it's members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation. If dogs are found in distress, CNYSSC will take appropriate action.

By entering the event premises, you are entering an area where photography, audio and video recording may occur.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

Our club has made the decision to allow the Show Chairperson's owned, co-owned, or named as breeder on dogs to be shown during this show. The Show Chairperson or partner are not be allowed to show these dogs in the confirmation ring themselves but are allowed to have others show them in their place. These dogs are allowed full placement rights equal to all other dogs competing. The Show Chairperson may show their own dogs in Obedience or Rally.
