Please note the change in ring location from previous years' shows. Ring #2 is the corner ring adjacent to Emerald Street.

Judges are not required to wait for dogs. Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called. All dogs present must be on leash or confined to their crates except when being judged.

The show will be open from 8:00 a.m. to 6:00 p.m.

Exhibitors will be responsible for clean conditions in and around their areas. If we are to have access to these grounds in the future, exhibitors and handlers must keep them clean.

**From Route 95 North & South:** Take Exit 6B to 495 North to Exit 15 (RT 1A). At the end of the ramp, follow Route 1A North for 3 miles; stay on Route 1A; go past the intersection on Rte. 140. Take left at blinking yellow light (North St.), Turn left on Emerald Street and follow the signs.

**From the west:** Take the Massachusetts Turnpike (I-90) East to 495 South to Exit 15. Take left at the end of the ramp, follow directions above.
