Show set-up: Any time after 12:00 p.m. on Wednesday.

Limited electric will be available on show grounds for the cost of \$25 for both days.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

Please keep the area cleaned up with the equipment provided. If we are to have access to these facilities again, exhibitors and handlers MUST keep them clean.

There will be no smoking inside the building. Please dispose of trash in the proper manner.

There will be a food vendor on site both days for breakfast and lunch.

Parents must be responsible for children. Children must be kept under supervision at all times. No strollers please, for the safety of your child.

The use of flexi-leads is not prohibited on show grounds. However, we urge you to use them responsibly.

All dogs present must be on leash or confined to their crates except when being judged.
