## Notice To Exhibitors

### Dress Code: Casual!

**MOST IMPORTANT:** If you are exhibiting signs of illness, have tested positive or have been otherwise told to self-quarantine due to known Covid-19 exposure, please stay home.

Food will not be available onsite. Please plan to bring your own lunch, water, ice, etc.

**Masks:** As of the publishing of this premium, the wearing of masks is optional. However, we will follow facility, local and state guidance at the time of the show. Judges may require wearing of masks while in their ring. Any policy changes will be announced and posted at the show site. Exhibitors are expected to follow all mask mandates in place at the time of the show, please come prepared to wear a mask if required.

**As a courtesy, if the judge in the ring is wearing a mask, please plan on wearing a mask while in their ring.**

Show set-up/Parking/Loading-Unloading: Any time after 2:00 p.m. on Wednesday. [There is plenty of parking space. Please respect the "no parking" signs around the pavilions. If ground conditions permit, unloading into the pavilions will be permitted from the "no parking" areas until judging begins, but vehicles must be moved quickly to a regular parking area. Spaces will be reserved for Judges and Show Committee.](#)

Limited electric will be available on show grounds. See pricing in premium list.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called. [Unentered dogs are not permitted in the pavilions.](#)

Please keep the area cleaned up with the equipment provided. If we are to have access to these facilities again, exhibitors and handlers MUST keep them clean.

There will be no smoking inside the building. Please dispose of trash in the proper manner.

Parents must be responsible for children. Children must be kept under supervision at all times. No strollers please, for the safety of your child.

The use of flexi-leads is not prohibited on show grounds. However, we urge you to use them responsibly.

Free admission/Free parking. See special RV Parking information in premium.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

All dogs present must be on leash or confined to their crates except when being judged.

A limited number of show catalogs will be available for \$8.00 each.

**IMPORTANT!** Transfers of dogs from regular classes to Best of Breed/Variety Competition and transfers of dogs determined to be ineligible for the class in which is has been entered to an Open class (Ch. 11, Sec. 6, AKC Rules Applying to Dog Shows) must be made to the Show Secretary at least 1/2 hour prior to the start of any regular conformation judging at this show.

Rally Transfers will be permitted in accordance with Rally Regulations Ch. 1, Sec. 15 and must be made at least 1/2 hour prior to the start of Rally judging.

### Directions to Emergency Clinic from Show Site:

Drive towards Midway Road and continue on Harlansburg Rd. (PA-108) – approx. 4 miles. Turn Right on Perry Highway (US-19) and travel 4.3 miles. Take ramp onto US-422 toward Butler and travel 1.52 miles. Take ramp onto I-79 S (Pittsburgh) and travel 27.93 miles. Take Left fork onto I-279 towards Pittsburgh – travel 4.5 miles. Take Exit #8/Camp Horne Road – travel .38 mile. Turn Right on Camp Horne Road – travel .21 mile. The Clinic is on the Right. Total travel time: 48 minutes/42.78 miles.
