- Grooming allowed ONLY in designated grooming rooms. See RSVP form for reserved grooming spaces.
- Anyone whose dog is seen soiling any interior place, carpet, etc. will be charged \$75.00 by the Hotel if it is not cleaned immediately. It will be added to your bill. All officers and members of the club will be "on duty." Anyone caught letting their dog soil anywhere inappropriate will be reported to the hotel and they will be billed for cleanup.
- Exhibitors, Owners & Agents assume all responsibility for dogs and equipment on the show site.
- Each exhibitor is responsible for keeping their grooming area and ex-pen clean and orderly. All waste and residue must be cleaned up and properly dispose of before leaving the site.

- No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.
- There will be no smoking in the building.
- **Disturbances or altercations by attendees or their dogs brought forth by hotel staff to the LPWCC Show Committee are considered impairment of a Club's ability to retain a site and may be subject to an event committee hearing.**
- **Transactions involving the sale or transfer of Pembroke Welsh Corgis are prohibited on the show grounds which include the Holiday Inn Crystal Lake and its entire property.**
