Clean-up is the sole responsibility of the owner. Please use designated areas only for potty breaks. Community Exercise pens will be available for your use as a convenience. Please use plastic under crates. Guest rooms will be subject to random inspection by the hotel staff and show committee. The hotel grounds and hotel rooms are considered part of the show grounds. Misconduct or destruction of hotel property will be cause for an Event Committee Hearing.

**SOME AREAS OF THE HOTEL / show site are off-limits to dogs.** These include: All areas that serve food and beverages; Recreation areas including the Pool and Health and Fitness Room; and Public restrooms.

**FIRE LANES** and designated areas must be kept clear. No parking in these areas.

# Notice to Exhibitors

**The Show Grounds will be Open** from 3:00 PM on Monday, April 14th through Friday April 18th.

**Dogs May Arrive** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**Judges are not required to wait for dogs.** They will adhere as closely as possible to the Judging Schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when it is scheduled to be judged. The show-giving Club and the show secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**No Dogs will be allowed in the Show Area** except those regularly entered in the show. There will be **NO SPACE** for unentered dogs at this show.

**PLEASE NOTE:** No entry may be changed or canceled unless notice of the change or cancellation is received **in writing** by the Show Secretary named in the premium list to receive entries, prior to the closing date and hours for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve-to-Eighteen Month Class at a show prior to the judging, and except that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such errors. (American Kennel Club Rule, Chapter 11, Sect 6.)

**It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.**
