- No set-ups within 10 feet of the ring. All set-ups must be removed at the conclusion of the show.
- Owners and handlers will be held responsible for clean conditions in and around crating area.
- Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further
 judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when
 required and without being called.
- All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Proof of Rabies Vaccination is recommended.
- PLEASE DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES. The MWDC reserve the right to remove any animal in distress
 from a parked vehicle or crate, and all persons attending this show hereby waive any claim for damages against MWDC or DCA or
 their members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper
 ventilation.
- **IMPORTANT!** Transfers of dogs must be made to the Show Secretary no later than ½ hour prior to the scheduled start of judging. 8:30 AM Saturday for Obedience, 10:00 AM Saturday for Rally, 9:30 AM Sunday for the AM Specialty, and 12:30 PM for the PM Specialty.

Directions

Frederick County Fairgrounds: 155 Fairgrounds Road, (Route 11) Clear Brook, Virginia 22624

Frederick County (VA.) Fairgrounds are located one mile off Interstate 81 at exit 321 on Route 11.

From the North: take exit 321 to stop sign, turn left, and proceed to the red light. Turn right, fairground is on the right.

From the South: take exit 321 to stop sign, turn right and proceed to the red light. Turn right, fairgrounds will be on the right.

From the East or West: take Route 7 or I-66 to I-81 North and follow directions above.

Body Renew Fitness: 221 Commonwealth Court, Winchester, VA

From the North or South: Interstate 81, Exit 310 (Kernstown). Take Route 37 and immediately take Route 11 North about 2/10 of a mile to Commonwealth Court. Go right past Camping World, around the circle. Body Renew is to the left. Take the driveway along the left side (as you enter the parking lot) of the building. Enter at the door marked Blue Ridge Dog Training Club.
