Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart on the left.) At the 2nd light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distance after the turn.

From **DC & Virginia:** From DC Beltway (I-495) take I-270 exit towards Frederick. From 270, take Damascus exit (Route 27 North). Stay on 27 North approx. 25 miles to Main Street in Westminster. Turn right onto Main Street. Go 1.5 miles. C.I.S.C. will be on right side of road after crossing over Route 97.



Travel approximately 1.5 miles and make a U-Turn at the Motor Vehicle Administration (MVA) sign. 1030 Baltimore Blvd. is on the Right, approximately 1/4 mile after the U-Turn.

NOTICE TO EXHIBITORS

Grooming and Crating Information (see site map below):

- No grooming inside the building.
- A grooming tent will be available outside the back door. There will be no electric, and space will be limited. Please use the tent for grooming only.
- There is plenty of indoor crating. Bring ground cover (mats or tarps) for under your crate. No ex-pens indoors.



- Show set-up is on Friday at 7:00 a.m. No set-up will be available on Thursday.
- There is a snack bar onsite and other food available close to the site. No outside food is allowed.
- Judging will begin promptly as scheduled. Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.
- Please keep these areas cleaned up with the equipment provided. If we are to have access to these facilities again, exhibitors and handlers MUST keep them clean.
- Accidents happen, but PVGRC would like to keep them to a minimum (or not at all!) since the club will be fined for all accidents.
- Please dispose of trash in the proper manner.
- Parents must be responsible for children. Children must be kept under supervision at all times. While the use of flexi-leads is not prohibited on show grounds, we urge you to use them responsibly.
- Free admission/Free parking. Parking is strictly at the exhibitor's risk as the Club
 accepts no responsibility for theft, damage or loss of personal property or the loss of or
 injury to animals in the care of the exhibitors at the show.
- No electrical hookups are available. No gasoline or diesel generators within 100 feet of any area in which this dog show is conducted.
- All dogs present must be on leash or confined to their crates except when being judged.
