## Exhibitor Information

- Exhibitors, Owners & Agents assume all responsibility for dogs and equipment on the show site. Each exhibitor is responsible for keeping their grooming area and ex-pen clean and orderly. All waste and residue must be cleaned up and properly disposed of before leaving the site.
- All dogs present must be on leash or confined to their crates except when being judged. No flexi-leads inside the show building. Dogs may not be left overnight.
- There will be no smoking in the building. No gasoline or diesel generators within 100 feet of any area in which this dog show is conducted.
- Bathing and grooming are **not** allowed in hotel rooms. An outdoor bathing facility will be provided.
- Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. **The judge is not required to wait for dogs.** It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.
- Parents must be responsible for children. Children must be kept under supervision at all times.
- Free admission / Free auto parking. RV parking rates listed on RSVP page.
- Food concession will be available Thursday and Friday. There is an on-site Restaurant that serves breakfast and dinner.
- **We encourage you to bring your own chair.** Limited seating will be provided and is on first come, first served basis. There will be no reserved seating of facility chairs at any time during the show. Any placards or other identification used to "save" seats will be removed by the Show Committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. PWCCP is not responsible for the behavior of the attendees or their dogs. If attendees' dogs create an unsafe situation for other attendees or their dogs, the owners of misbehaving dogs remain liable for any damages and may be asked to leave. In such case, no refund of any fees paid will be made.

## COVID Information

As of the publishing of this judging schedule, we expect the show to go on as described. All show decisions will be in accordance with Maryland state, local, event and facility guidelines in place at the time of the show. Face masks are not presently required, full indoor crating and grooming will be allowed. Any changes, including the mask wear policy, will be posted/announced at the show site. Please bring your own mask with you just in case the policy changes, as none will be provided. PWCCP is making every effort to supply a safe show environment. However, exhibitors are entering and attending the shows at their own risk.
