Classes for dogs & bitches 7 years and over. Sexes divided. Winners of the Veteran Classes may compete in Best of Breed Competition if otherwise undefeated the day of the show. A rosette will be presented to each Veteran competitor. The AKC allows spayed bitches and castrated dogs to be shown in the Veterans Class at Independent Specialty Shows, and are eligible for competition in Best of Breed. *Chapter 11, Section 8 of the Dog Show Rules.*

NON-REGULAR CLASSES

Involving Multiple Dog Entries

Generations Class*

Class will not be divided by sex. This class is for a dog or bitch to be shown with a son or daughter and a grandson or granddaughter (only one dog of each generation for a total of three dogs shown - first to third generation). The grandson or granddaughter need not be the offspring of the son or daughter. Owner of the dog or bitch need not be the owner(s) of the son/daughter or grandchildren. Award will be based on the merits of the group. Entry fee for this class is \$30.00 if the dog or bitch is NOT individually entered in a class in this show. If already entered in a class, the fee for the unit is \$25.00. Get MUST be individually entered in one of the classes in this show for which it is eligible.

Stud Dog/Brood Bitch Class*

For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and shown in the ring with their Get. Owner of the Stud Dog need not be owner of the Get. Award will be based on the merits of the Get. Each unit of 3 (Stud Dog and 2 Get) shall be an entity unto itself. Stud dog or his Get may not be part of another unit. Entry fee for this class is \$30.00 if the Stud Dog snot already entered in a regular class. If already entered in a regular class the fee for the unit is \$25.00. Get must be individually entered in one of the breed classes in this show for which it is eligible. Brood Bitch same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class*

Each Brace shall be composed of two dogs of either sex owned by identical owner. All braces must be entered in the Brace Class and shown in the ring at the same time. Dogs entered in Brace Class do not have to be entered in any other class. Entry fee is \$30 for the unit.

*As a judge's decision in the Stud Dog, Brood Bitch, and Brace Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won this class. Novice Class: For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, have not won three first places with competition present in a Novice Class at a licensed or member show.

Open Class: This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club® are limited to competing in the Open class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

Master Class: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All Juniors meeting the criteria for this class are quired to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

The dogs need not be owned by the same person, but must be handled by one handler. Dogs may be shown unattached or coupled—the coupling device not to be less than is inches in overall length; whichever method is used must be continued throughout all exercises. A separate Official Entry Form must be completed in full for each dog entered. Exercises, performances and judging shall be as in the Novice Class. The Brace should work in unison at all times. Either or both dogs in a Brace may be entered in another class or classes at the same trial. Entry fee for the Brace Unit is \$30

- 1 (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in, but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division,
- A dog must be entered in the name of the person who actually owned it at the time the entries for a show closed. If a 4 registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of the acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
- 5 Mixed Breed Dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
