### Notice to Exhibitors

The church will be hosting an event this weekend. Please be respectful and follow any posted signs regarding parking or other logistics.

- To protect the floors, **floor covering is required** under grooming and crate set-ups. A limited number of tarps will be available for purchase for a nominal fee at the show site. **No chalking in building**. The club is responsible for scrubbing the floors, please keep chalk use to a minimum.
- Set-Up: There is no set up Thursday night. The building will be available for set-up once the rings and tables are set on Friday, likely to be no earlier than 9 AM. On Saturday, the building will open at 7:30 AM, and will close one hour after the conclusion of judging. Dogs may not be left overnight. No guard will be on duty. DO NOT BLOCK access from our trailer to the doors. The longer it takes us to set up, the later exhibitors will be allowed in.
- A designated loading/unloading zone will be provided. Please use it in the spirit that it is intended and move quickly to a regular parking place. Spaces will be reserved for Judges and Show committee. There is still \*PLENTY\* of parking near the building.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Licensed Events.
- Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.
- All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.
- The Host clubs, the Show Secretary, or their members or agents assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property; and further assume no responsibility for any injury to children in attendance.
- Due to the special church event, breakfast and lunch will **NOT** be available on Friday. Light snacks will be available for a donation.
- Breakfast and lunch **WILL** be available on Saturday.
- IMPORTANT! Transfers of dogs from regular classes to Best of Breed/Variety Competition and transfers of dogs determined to be ineligible for the class in which it has been entered to an Open class (Ch. 11, Sec. 6, AKC Rules Applying to Dog Shows) must be made to the Show Secretary at least 1/2 hour prior to the start of any regular conformation judging at this show.
