NOTICE TO EXHIBITORS

The building will be open for setup on Friday evening no earlier than 4 p.m, and after the ring and club tables have been set. Please allow yourself additional travel time, as Friday traffic in the DC/Baltimore area can be heavy. The building must be vacated one half hour after the end of judging on Friday.

The building will open on Saturday morning at 7:30 a.m. The building must be vacated one hour after the end of judging on Saturday.

There will be NO SETUP DURING SWEEPSTAKES JUDGING to begin FRIDAY at 7:00 P.M.

Judging will be indoors. Expanded grooming area will be available indoors. No chalking in building—covered chalking area will be available.

Floor covering is required under grooming and crate set-ups. A limited number of tarps will be available for purchase for a nominal fee at the show site. Owners and handlers will be held responsible for clean conditions in and around crating area.

Crates and tables may be left overnight on Friday. The building will be LOCKED. NO DOGS MAY BE LEFT OVERNIGHT.

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. It is the responsibility of the owner or handler to have the dog at ringside when its class is called. Dogs not required for further judging will be excused.

All dogs present must be held on leash or confined to their crates except when being judged. Please keep dogs on leash at all times.

All prizes will be awarded in the ring when judging of that class is over. None will be mailed.

There will be no smoking on the show grounds. Please dispose of all trash in the proper manner. Please help keep our show grounds clean!!

Please bring your own chairs.

Good food will be available on Saturday

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of external parasites, any communicable diseases and have appropriate vaccinations.

IMPORTANT NOTE: The water in the facility is not drinkable. Please bring water for your dogs. Bottled water will be available.
