No puppies under 4 months of age on show grounds.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. There will be no smoking inside the building. Please dispose of trash in the proper manner.

Exhibitors providing email addresses may receive all communication, including confirmation and judging schedule through email. Please ensure all spam-blocking technology is set to allow email from showsec@clantyre.net.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/ or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
