Notice To Exhibitors

The show grounds will be available to exhibitors after 7:00 PM the night prior to the show.

Food will be available.

There are limited camper hook-ups. Fees are payable to the fairgrounds when you arrive. No reservation will be accepted.

****IMPORTANT NOTE****

Owners and handlers will be held responsible for clean conditions in and around crating area. All persons are responsible for picking up after their dogs. Anyone not picking up after their dog will be asked to leave the show grounds. Please dispose of trash in the proper manner.

Dogs may not be left at the show grounds overnight.

All dogs present must be on leash or confined to their crates except when being judged.

Dogs need to be at the show only at the scheduled time of judging and may leave immediately thereafter unless required for further judging. The judge is not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when required and without being called.

Free admission. Free parking on the day of the show.

No gasoline or diesel generators inside any building or within 100 feet of any area in which this dog show is conducted.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage, illness or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Dogs may not be left in closed vehicles without proper ventilation. If dogs are found in distress, WMSSC will take appropriate action. All persons attending this show hereby waive any claim for damages against the club and its members for such removal.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Exhibitors must carry a copy of their dog's rabies certificate.

This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

NOTE EXIT NUMBER CHANGES!

Massachusetts Turnpike (Route 90): Exit **41**. Turn right at the end of the ramp, take your next right (Arch Rd). Take a left on Cabot Rd. Proceed to the end of the road. Turn right onto Russellville Rd. Fairgrounds are on the right.

I-91: Take exit **12** (Holyoke Mall), turn left at the bottom of the ramp. At the second set of lights, turn right (Homestead Ave). At the next light, turn left (RT 202), go approx. 5 miles, cross RT 10. Proceed past the cemetery on the left then turn left at the stop sign. The show site is on the left approx. 1.5 miles.
